Especially helpful for servicemembers and families who live well away from military installations, as most Reserve Component members do.

All of the databases available via Military OneSource, plus several others, are available here. Also includes resources by subject, QuestionPoint online reference service, and subject bibliographies. The other services all have similar portals.

-Guard and Reserve members who have deployed to Iraq or Afghanistan are eligible for five years of free VA health care for any service-related condition. They can use the VA Health site to get health information, find your nearest VA health center, apply for benefits and contact VA with any questions.

G. Legal Resources:

Servicemembers' Civil Relief Act (SCRA):

Federal law covering all active-duty servicemembers, including mobilized Guard and Reserve members. The bill limits interest on pre-existing debts (credit cards, loans, mortgages, etc.) to 6% (the servicemember must request SCRA protection in writing). Also, the law provides protection against property seizures, foreclosure, eviction and default judgments:

Uniformed Services Employment and Reemployment Rights Act (USERRA):

Federal law protecting the civilian employment rights of Guard and Reserve servicemembers called to active duty. The bill prohibits employers from punishing or discriminating against employees because of their military commitment. Under the terms of USERRA, returning servicemembers must be reemployed in the job they would have obtained had they not been mobilized. If gone for over 180 days, the servicemember has up to 90 days to return to work. Servicemembers must give their employers advanced notice of absences for military duty, if possible:
